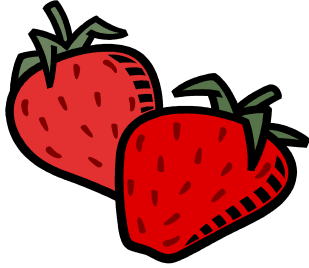
A bill change booth will not be available this year. Please plan accordingly.

New vendors, premium booths are limited, generally new vendors will not have a premium space, as prior vendors have priority. If you apply for a premium booth and one is not available a standard booth will be assigned, unless you state you only want a premium booth on the application. The booth fee difference will be given to you at the event. If you authorize the charging of the fee to a credit card, the lesser amount will be charged.
